**INDEMNITY.** In further consideration of the opportunity to participate and/or volunteer in Wichita Corporate Challenge, I hereby agree to indemnify and hold harmless the Released Parties from and against any and all claims of third parties, including but not limited to fellow employees and members of the public, for personal injury, illness, property damage, and/or claims arising from exposure to the Novel Coronavirus (COVID-19) which may result from or be caused by my own intentional, deliberate or negligent conduct. This indemnity shall survive regardless of when such claims are asserted.

- Comply with all policies and guidelines in place, including but not limited to face coverings/masks, social distancing, and host facility protocols. Participants and/or volunteers that fail to adhere to safety guidelines will be removed from an event at the discretion of the Corporate Challenge Games Director, or his or her designee.
